



**DISCLOSURE ON OWN SHARES' PURCHASE IN THE PERIOD

Venezia-Mestre, 31 October 2018 - OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on the *Mercato Telematico Azionario*, in the period 26 October and 30 October 2018, no. 27,000 ordinary shares (equal to 0.012% of the share capital) at the average unit price of EUR 1.4844 for a total amount equal to EUR 40,077.99.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of last May 31st, 2018 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
