

NOMINATION PROPOSALS for the BOARD OF DIRECTORS

Mestre, May 9th, 2019 - With reference to the next Shareholders' Meeting convened for May 31st, 2019 in single call and, in particular, to the items referred to in items no. 6 and 7 of the ordinary part on the agenda, the Company discloses that, with reference to item 6, "Integration of the Board of Directors pursuant to Article 2386 of the Civil Code and Article 13 of the Bylaws. Appointment of the Chairman of the Board of Directors. Related and consequent resolutions.", the following proposals were received:

- 1) the shareholders Arca Fondi S.G.R. S.p.A., manager of the funds: Arca Azioni Italia and Arca Economia Reale Bilanciato Italia 30; BancoPosta Fondi SGR, manager of the funds: Bancoposta AZ Internazionale, Bancoposta Mix 1, Bancoposta Mix 2 and Bancoposta Mix 3; Fideuram Investimenti SGR S.p.A., manager of the funds: Piano Azioni Italia, Piano Bilanciato Italia 50 Plan and Piano Bilanciato Italia 30; Mediolanum Gestione Fondi SGR S.p.A., manager of the funds: Mediolanum Flessibile Futuro Italia and Mediolanum Flessibile Sviluppo Italia; Mediolanum International Funds Limited - Challenge Funds - Challenge Italian Equity, which together hold a share equal to 3.89% (no. 8,833,507 shares) of the share capital, has proposed the candidacy of:
 - (i) Elena Garavaglia;
- 2) the shareholder Tamburi Investment Partners S.p.A., which holds a share equal to 22.747% (no. 51,635,898 shares) of the share capital has proposed the candidacy of:
 - (i) Giovanni Tamburi
 - (ii) Alessandra Gritti
 - (iii) Massimiliano Magrini
 - (iv) Franco Moscetti

Elena Garavaglia, Massimiliano Magrini and Franco Moscetti have declared to hold the independence requirements pursuant to the TUF and the Corporate Governance Code.

It should be noted that Elena Garavaglia, Giovanni Tamburi, Alessandra Gritti and Massimiliano Magrini are members of the current Board of Directors since they were already co-opted; Elena Garavaglia on June 20th, 2018 and Giovanni Tamburi, Alessandra Gritti and Massimiliano Magrini on March 13th, 2019.

The shareholder Tamburi Investment Partners S.p.A. has, also, expressed proposal to appoint **Franco Moscetti** as **Chairman of the Board of Directors**.
