Venezia-Mestre, 03 March 2022 - OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on Euronext Milan, in the period 24 February 2022 and 2 March 2022, no. 247,941 ordinary shares (equal to 0.085% of the share capital) at the average unit price of EUR 2.17331 for a total amount equal to EUR 538,852.98.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of last May 28th, 2021 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
