



**DISCLOSURE ON OWN SHARES' PURCHASE IN THE PERIOD

Venezia-Mestre, 10 March 2022 - OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on Euronext Milan, in the period 3 March 2022 and 9 March 2022, no. 286,000 ordinary shares (equal to 0.098% of the share capital) at the average unit price of EUR 1.9104 for a total amount equal to EUR 546,384.22.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of last May 28th, 2021 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
