



**DISCLOSURE ON OWN SHARES' PURCHASE IN THE PERIOD

Venezia-Mestre, 30 June 2022 - OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on Euronext Milan, in the period 23 June 2022 and 29 June 2022, no. 229,368 ordinary shares (equal to 0.079% of the share capital) at the average unit price of EUR 1.6005 for a total amount equal to EUR 367,098.79.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of May 31st, 2022, in continuity with the own shares' purchase program started on February 2nd, 2022 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
